SUPPLEMENTARY DEED OF AGREEMENT
RUDOLF STEINER SCHOOL (CHRISTCHURCH)

THIS DEED made this 17 day of August 1992

BETWEEN THE RUDOLF STEINER SCHOOL TRUST (CHRISTCHURCH) a Trust incorporated under the Charitable Trusts Act 1908 (hereinafter referred to as "the Proprietor") of the first part

AND HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "the Minister") of the second part

WHEREAS by Deed of Agreement dated the 29th day of September 1989 (hereinafter referred to as "the Deed of Agreement") the Proprietor and the Minister pursuant to Section 7 (2) of the Private Schools Conditional Integration Act 1975 established the Rudolf Steiner School at Christchurch as an integrated school in accordance with the Act

AND WHEREAS the Proprietor and the Minister are now agreed on the need to amend the Deed of Agreement pursuant to Section 7 of the Private Schools Conditional Integration Act 1975 to provide for certain changes that have occurred since the 29th day of September 1989.

NOW THEREFORE this Deed witnesseth that it is hereby covenanted agreed and declared by and between the parties hereto as follows:

1. THAT the words "two hundred and sixty (260) pupils" in the first line in Clause 8 of the Deed of Agreement be deleted and the words "three hundred and twenty (320) pupils" be substituted therefore.

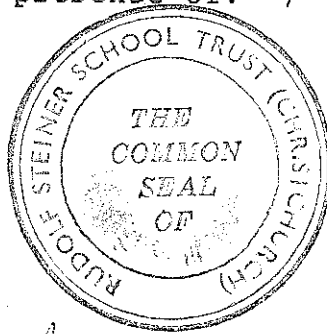
