THIS DEED OF AGREEMENT made the 23rd day of June 1998

BETWEEN THE NEW ZEALAND SEVENTH-DAY ADVENTIST SCHOOLS ASSOCIATION LIMITED a duly incorporated company having its registered office at Auckland (with its successors referred to as "the Proprietor")

AND HER MAJESTY THE QUEEN acting by and through the Minister of Education ("the Minister")

BACKGROUND

- A. By Deed of Agreement dated 28th January 1993 ("the Deed of Agreement") the Minister and the Proprietor pursuant to Section 7(2) of the Private Schools Conditional Integration Act 1975 established **SOUTH AUCKLAND SEVENTH-DAY ADVENTIST PRIMARY SCHOOL** as an integrated school ("the School").
- B. By supplementary agreement dated 28 June 1997 (the "First Supplementary Agreement") the Minister and the Proprietor amended clause 20 of the Deed of Agreement.
- C. The Proprietor and the Minister are now agreed on the need to further amend clause 20 of the Deed of Agreement.

THE PARTIES AGREE:

- 1. The words "maximum roll of the School shall be 230" in line 4 of Clause 20 on page 6 of the Deed of Agreement as amended by the First Supplementary Agreement to refer to the "maximum roll of the School shall be 255" be deleted and substituted with the words "maximum roll of the School shall be 285".
