## SUPPLEMENTARY DEED OF AGREEMENT

## STS PETER & PAUL SCHOOL, LOWER HUTT

THIS DEED OF AGREEMENT is made on the day of New Vac two thousand (2000) BETWEEN THE ROMAN CATHOLIC ARCHBISHOP OF THE ARCHDIOCESE OF WELLINGTON a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part and HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

## **WHEREAS**

- A By Deed of Agreement bearing date the twentieth (20<sup>th</sup>) day of November, one thousand, nine hundred and eighty-one (1981) as varied by subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **Sts Peter & Paul School**, **Lower Hutt** as an integrated school (hereinafter referred to as "the School").
- <u>B</u> The Proprietor and the Minister wish to vary the Deed of Agreement to decrease the maximum roll pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1 THAT the words "five hundred and ten (510) pupils" in the 5th line in clause 8 of the Deed of Agreement be deleted from that Agreement and the words "four hundred and sixty (460) pupils" be substituted therefor.
- 2 THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
