

SUPPLEMENTARY DEED OF AGREEMENT

STS PETER & PAUL SCHOOL, LOWER HUTT

THIS DEED OF AGREEMENT is made on the *28* day of *March* two thousand and twelve (2012) **BETWEEN THE ROMAN CATHOLIC ARCHBISHOP OF THE ARCHDIOCESE OF WELLINGTON** a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

WHEREAS

- A** By Deed of Agreement bearing date the twentieth (20th) day of November, one thousand, nine hundred and eighty one (1981) as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **Sts Peter & Paul School, Lower Hutt** as an integrated school (hereinafter referred to as "the School").
- B** The Proprietor and the Minister wish to vary the deed of Agreement to amend Clauses 8 and 10(b) of the Deed Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.


NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. **THAT** the words "four hundred and sixty (460) pupils" in line five of Clause 8 of the Deed of Agreement be deleted and the words "four hundred and eighty five (485) students" be substituted therefor.
2. **THAT** in clause 10(b) of the Deed of Agreement the words "twenty five (25) pupils" be deleted from that Agreement and the words "twenty four (24) students, five percent (5%)" be substituted therefor.
3. **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
