SUPPLEMENTARY INTEGRATION AGREEMENT

SUPPLEMENTARY DEED OF AGREEMENT

THIS DEED OF AGREEMENT made on the 31st day of July

Two Thousand (2000) BETWEEN **THE RUDOLF STEINER SCHOOL HASTINGS TRUST**, a Trust incorporated under the Charitable Trusts Act 1998 (hereinafter with its successors referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Ministry of Education (hereinafter referred to as "The Minister") of the second part.

WHEREAS

- A By Deed of Agreement bearing date the 21st day of January 1991 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7 (2) of the Private Schools Conditional Integration Act 1975 Rudolf Steiner School Hastings established as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to amend the Deed of Agreement by changing the name of the school pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

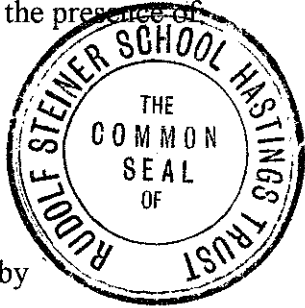
- 1 THAT wheresoever they appear in the Deed of Agreement the words "**Rudolf Steiner School Hastings**" be deleted and the words "**Taikura Rudolf Steiner School**" be substituted therefor.
- 2 THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
