The Stewards Trust of New Zealand Incorporated, being the proprietor of the Tasman Bay Christian School, the said proprietor being duly incorporated under the Incorporated Societies Act 1908 (hereinafter together with its successors and assigns called the Proprietor) of the first part

and

Her Majesty the Queen acting by and through the Minister of Education (hereinafter called the Minister) of the second part

whereas

- A. The Proprietor and the Minister pursuant to Section 7(2) of the Private Schools Conditional integration Act 1975 signed an integration agreement on the 14th August 1995 for the establishment of the Tasman Bay Christian School (Hereinafter referred to as the original Deed of Agreement)
- B. The Proprietor and the Minister pursuant to Section 7(9) of the Private Schools Conditional Integration Act 1975 subsequently varied the original Deed of Agreement by a supplementary Agreement bearing the date 22 June 1999 which provided for major maintenance funding
- C. Furthermore the Proprietors and the Minister pursuant to Section 7(9) of the Private Schools Conditional Integration Act 1975 subsequently varied the original Deed of Agreement by a Supplementary Agreement bearing the date 19th May 2000 which provided for an increase in the roll from 28 to 60 pupils.
- D. The Proprietor and the Minister are now agreed on the need to amend Clause 22 and Clause 23 of the Original Deed of Agreement and of the Supplementary Agreement pursuant to Section 7(9) of the Private Schools Conditional Integration Act 1975.

Now this deed of agreement witnesseth that it is hereby covenanted, agreed and declared by and between the parties hereto as follows:-

That clause 22 of the Original Deed of Agreement shall be amended as follows:

Line 3 "that the maximum roll of the school shall be 75."

That clause 23 (b) of the Original Deed of Agreement shall be amended as follows:

Line 5 & following "shall be limited to 6 pupils."
