

## DEED OF AGREEMENT

### VILLA MARIA COLLEGE, CHRISTCHURCH

THIS DEED OF AGREEMENT is made on the 8<sup>th</sup> day of April one thousand nine hundred and ninety-eight (1998) BETWEEN VILLA MARIA COLLEGE CHRISTCHURCH LIMITED (hereinafter with its successors referred to as "the Proprietor") of the first part and HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

### WHEREAS

- A By Deed of Agreement bearing date the 9<sup>th</sup> day of October 1981 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **Villa Maria College, Christchurch** as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to change the class of the school to a **Years 7 to 13 school** consequent upon the closure of **the attached Intermediate Department of the School** and to amend **Clause 8** of the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

**NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:**

- 1 THAT the Integration Agreement be amended as follows:
- 2 By deleting from **Recital B** the words "Form Three (III) to Form Seven (VII) with an attached Intermediate Department" and substituting the words "Years 7 to 13" therefor.
- 3 By deleting **Clause 8** and substituting the following Clause therefor: "On the 1<sup>st</sup> day of March 1998 the combined rolls of Villa Maria College and the attached Intermediate Department totalled seven hundred and fourteen (714) pupils. It is agreed by and between the parties hereto that the maximum roll of the school shall be seven hundred and fifty (750) pupils."
- 4 By deleting from **Clause 23** the words "from Form Three (III) to Form (VII) with an Intermediate Department attached" and substituting the words "from Years 7 to 13" therefor.

- 5 By deleting **Clause 17** of the Deed of Agreement.
- 6 By deleting from lines 1 and 2 and from lines 14 of **Clause 18** of the Deed of Agreement the words "the Form III to Form VII section of".
- 7 By deleting the **Fourth Schedule** to the Deed of Agreement.
- 8. **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
