

## SUPPLEMENTARY DEED OF AGREEMENT

### WA ORA MONTESSORI SCHOOL, LOWER HUTT

THIS DEED OF AGREEMENT is made on the 31 day of August two thousand and twelve (2012) BETWEEN **WA ORA MONTESSORI SCHOOL INCORPORATED** (the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

### WHEREAS

- A By Deed of Agreement bearing date the 10<sup>th</sup> day of September 1993 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **Wa Ora Montessori School, Lower Hutt** as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to amend clause 20 and Background C of the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

### NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:


1. **THAT** the words "one hundred and sixty (160) pupils" in line 4 of Clause 20 of the deed of Agreement be deleted and the words
  - i. "two hundred (200) places from August 2012
  - ii. two hundred and forty (240) places from January 2013
  - iii. two hundred and eighty (280) places from January 2014to allow for accommodation on the new secondary site to be developed" be substituted therefor.
2. **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
