## WHEREAS:

- A. By Deed of Agreement bearing dated the 22<sup>nd</sup> day of February 1983 as varied by subsequent Supplementary Agreements (hereinafter referred to as "the Integration Deed of Agreement"), the Minister and the Proprietor pursuant to Section 7(2) of the Private Schools Conditional Integration Act 1975 established <u>WAIKATO</u>

  <u>DIOCESAN SCHOOL FOR GIRLS, HAMILTON</u> as an integrated school.
- B. The Proprietor and the Minister are now agreed to vary the terms of the Integration Deed of Agreement in particular clause 16 thereof.

## NOW THIS DEED WITNESSETH AND IT IS HEREBY AGREED AND DECLARED BY AND BETWEEN THE PARTIES AS FOLLOWS:

- 1. That clause 16 of the Integration Deed of Agreement is deleted and the following clause substituted:
  - "16. Unless the Proprietor and Secretary of Education otherwise agree, and subject to places being available, the number of pupils whose parents do not have preference of enrolment under the provisions of Section 29 of the Act shall be limited to seven and one half per centum (7.5%) of the maximum role of the school as approved from time to time."
- In all other terms and respects the covenants conditions and restrictions contained and implied in the said Integration Deed of Agreement are hereby confirmed.
