

THIS SUPPLEMENTARY DEED OF AGREEMENT is made on the 3rd day of
May 2001

BETWEEN RUDOLF STEINER SCHOOLS (WAIKATO) TRUST a duly constituted
Board pursuant to a certain Deed of Trust dated this 27th day of February 1981
(hereinafter with its successors referred to as 'the Proprietor') of the first part

AND HER MAJESTY THE QUEEN acting by and through the Minister of Education
(hereinafter referred to as 'the Minister') of the second part

WHEREAS

- A. By Deed of Agreement dated 15 December 1997 (hereinafter referred to as the "Deed of Agreement"), the Minister and Proprietor, pursuant to s 7(2) of the Private Schools Conditional Integration Act 1975 established WAIKATO WALDORF SCHOOL (RUDOLF STEINER INITIATIVE) as an integrated School (hereinafter referred to as "the School").
- B. The Proprietor and the Minister agreed to amend clause 8 of the Deed of Agreement by way of a Supplementary Deed of Agreement dated 25 August 1998 (hereinafter referred to as the "1998 Deed of Agreement").
- C. The Proprietor and the Minister are now agreed to amend clause 8 of the Deed of Agreement and clause 1 of the 1998 Deed of Agreement, pursuant to s 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSES THAT IT IS HEREBY
COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES
HERETO AS FOLLOWS:-

1. THE phrase "52 pupils" in line 2 of clause 8 to the Deed of Agreement and the phrase "125 pupils" in line 2 of clause 1 to the 1998 Deed of Agreement shall be deleted and substituted with the phrase "160 pupils".

2. THE covenants, conditions and restrictions contained in the Deed of Agreement shall be read and construed subject to the modifications herein, but in all other respects the Deed of Agreement shall continue in full force and effect.
