## SUPPLEMENTARY DEED OF AGREEMENT

### Bethel Christian School, Te Awamutu

THIS DEED OF AGREEMENT is made on the 4th day of two thousand and nine (2009) between Te Awamutu Bible Chapel Trust hereinafter referred to as "the Proprietor") of the first part and HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

### WHEREAS

- A By Deed of Agreement bearing date the **6th** day of **March 1998** as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 Bethel Christian School (hereinafter referred to as "the School") was established as an integrated school.
- B The Proprietor and the Minister are now agreed to vary the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

# NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY CONVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1. **THAT** wheresoever they appear in the Deed of Agreement, the words "Bethel Christian School" be deleted and the words "Waipa Christian School" be substituted therefore.
- 2. **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
