**SUPPLEMENTARY DEED OF AGREEMENT**

**WEST AUCKLAND ADVENTIST SCHOOL**

**THIS DEED OF AGREEMENT** is made on the *8th* day of *February* 1999.

**BETWEEN THE NEW ZEALAND SEVENTH-DAY ADVENTIST SCHOOLS ASSOCIATION LIMITED** a duly incorporated company having its registered office at Auckland (with its successors referred to as "the Proprietor) of the first part

**AND HER MAJESTY THE QUEEN** acting by and through the Minister of Education ("the Minister") of the second part

**WHEREAS**

- A. By Deed of Agreement bearing the date the 24th day of May 1993<sup>n</sup>, the Deed of Agreement<sup>n</sup> as varied by a subsequent Supplementary Agreement bearing date the 20th day of December 1996 (hereinafter together referred to as 'the Integration Agreements'), the Minister and the Proprietor pursuant to Sections 7(2) and 7(9) of the Private Schools Conditional Integration Act 1975 established the West Auckland Adventist Primary School as an integrated school (hereinafter referred to as "the School")
- B. The Proprietor and the Minister are now agreed on amending Clause 20 of the Deed of Agreement pursuant to Section 7(9) of the Private Schools Conditional Integration Act 1975 to further increase the maximum roll.


**NOW THIS DEED WITNESSES AND IT IS HEREBY AGREED BETWEEN THE PARTIES AS FOLLOWS:-**

1. That the words "maximum roll of the School shall be 25" in line 4 on page 6 of the Deed of Agreement be deleted, and the words "maximum roll of the School shall be 28" be substituted therefor.
2. That the terms conditions and agreement contained or implied in the Integration Agreements shall be read and construed subject to the modification herein contained by in all other respects the Integration Agreements are confirmed.




