

THIS DEED is made the seventh day of May 1979 BETWEEN  
THE WESLEY COLLEGE TRUST BOARD (formerly known as THE BOARD OF  
THE WESLEY TRAINING COLLEGE) being the Proprietor of Wesley  
College, Paerata, the said Proprietor being a Body Corporate in  
terms of Section 3 of the Methodist Charitable and Educational  
Trusts Act 1911 as amended by the Methodist Charitable and  
Educational Trusts Amendment Act 1976 and having its registered  
office at Ground Floor, Shell House, Auckland 1 (hereinafter  
together with its successors and assigns called the Proprietor)  
of the first part AND HER MAJESTY THE QUEEN acting by and through  
the Minister of Education (hereinafter called the Minister) of  
the second part:

WHEREAS FIRST the Minister and the Proprietor (under its former  
name the BOARD OF THE WESLEY TRAINING COLLEGE) pursuant to  
Section 7(2) of the Private Schools Conditional Integration Act  
1975 entered into a Deed of Agreement dated the 30th day of  
November 1976 whereby the said Wesley College was established as  
an integrated school.

SECOND the Minister and the Proprietor have pursuant to Section 9  
of the Private Schools Conditional Integration Act 1975 agreed to  
enter into this Supplementary agreement whereby the terms of the  
said Deed of Agreement are to be varied to make provision for an  
increased maximum roll.

NOW THIS DEED WITNESSETH THAT IT IS HEREBY COVENANTED, AGREED,  
AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1 The covenants conditions and restrictions contained and  
implied in the said Deed of Agreement are hereby varied as follows:

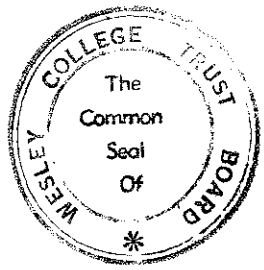
- a The number 275 where it appears at the commencement  
of line 4 of clause 6 of the said Deed of Agreement  
shall be deemed deleted as from the date of this  
supplementary agreement and replaced by the number 305.

b The number 55 in line 8 of clause 7 of the said Deed of Agreement shall be deemed to be deleted and replaced by the number 61.

2 The covenants conditions and restrictions contained and implied in the said Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the said Deed of Agreement is confirmed.
