1. DEFINITIONS:

"the Act" means the Private Schools Conditional Integration Act 1975.

"the Principal Deed" means the Integration Agreement made pursuant to section 7 of the Act and recorded by deed dated 30 November 1976 made between the Proprietor and the Minister and subsequently varied by Deed dated day of the 19

INCREASE IN SCHOOL ROLL - ADDITIONAL CLASSROOMS:

- Clause 6 of the Principal Deed is hereby amended to record that the maximum 2.1 school roll is increased to 380 pupils.
- 2.2 Pursuant to section 40(2)(d) of the Act the Minister hereby approves the provision by the Proprietor of two additional classrooms at its school (such classrooms upon completion to be part of the school premises referred to in the Principal Deed).
- The Proprietor acknowledges that the cost of providing the additional classrooms 2.3 is its responsibility.
- 2.4 All the other terms of the Principal Deed not varied or modified by the provisions of this Deed are hereby confirmed.
