

**SUPPLEMENTARY DEED OF AGREEMENT**

**WESTMINSTER CHRISTIAN SCHOOL, GLENFIELD, AUCKLAND**

THIS DEED OF AGREEMENT is made on the *31st* day of *October* two thousand and seventeen (2017) BETWEEN **WESTMINSTER CHRISTIAN SCHOOL INC.** a body Corporate registered under the Religious Charitable and Education Trusts Act 1957 (hereinafter with its successors referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

**WHEREAS**

- A By Deed of Agreement bearing date the 1<sup>st</sup> day of July 1998 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **Westminster Christian School, Glenfield, Auckland** as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to amend Clause 20 of the Deed of Agreement pursuant to section 423(3) of the Education Act 1989.

**NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:**

- 1 THAT the in the fourth line of Clause 20 the words "three hundred (300)" be deleted from the Integration Deed of Agreement and the word "four hundred (400), subject to you providing an additional four teaching spaces for a maximum roll of 400 students" be substituted therefor.
- 2 THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.





